Applicant proposes to construct a pool in the rear yard of a single family residence. Violation of the following sections (density modification subdivision):

- Section 124.12 Lot Area 31,500 SF required, 30,313 SF proposed; 1,187 SF variance requested
- Section 124.12 Lot Coverage 20% allowed, 23.4% proposed; 3.4% variance requested

No testimony or questions were offered by members of the public.

During testimony, as the property is located within a density modification subdivision, the Board agreed that the lot is undersized for the zone, creating the hardship of an existing condition. The Board agreed that the variances requested are conforming to the neighborhood therefore having no negative impact. The Board requested the following conditions of approval which the Applicant agreed to:

- Applicants shall comply with the recommendations of the Board Engineer's report dated 7/15/18.
- Any/all lighting shall comply with the Township's Land Use Ordinance and shall be installed downward facing.

Upon motion made by Mr. Johnson and seconded by Mr. Rosenberg, the board approved the variances requested with conditions subject to a memorializing resolution by the unanimous votes of Mr. Johnson, Mr. Rosenberg, Mr. Malloy, Mr. Gianakis, Mr. Verlezza and Vice Chairman/Acting Chairman O'Mullan; they being all of the Members present and eligible to vote.
