AUTHORIZING PROFESSIONAL SERVICES CONTRACT WITH SUPLEE, CLOONEY & COMPANY FOR INTERIM TOWNSHIP ADMINISTRATOR SERVICES

WHEREAS, the Township of Long Hill has a need to acquire the services of an interim Township Administrator; and

WHEREAS, the Finance Officer has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, contracts for professional services may be awarded without public bidding pursuant to *N.J.S.A.* 40A:11-5(1)(a)(I); and

WHEREAS, the Chief Financial Officer has certified in writing the availability of adequate funds to pay the maximum amount of this contract; and

WHEREAS, the contractor has submitted a proposal dated March 16, 2023; and

WHEREAS, the contractor has completed and submitted a Business Entity Disclosure Certification NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Long Hill, in the County of Morris, State of New Jersey, as follows:

- A professional services contract is hereby awarded to Suplee, Clooney & Company, a New Jersey
 partnership, having offices at 308 East Broad Street, Westfield, New Jersey, to provide interim township
 administrator services, in accordance with its proposal, for the following consideration: \$240,000, which is to
 be prorated for the balance of 2023, and which shall be payable in monthly installments of \$20,000.
- 2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with this resolution, and that notice of these awards be advertised once in the *Echoes Sentinel*.
- 3. The Contractor shall secure and maintain insurance with the following minimum limits:

Professional Liability/Malpractice \$1,000,000.00
Comprehensive General Liability \$1,000,000.00
Comprehensive Automobile Liability \$1,000,000.00

Workmen's Compensation Statutory

The certificates of insurance shall be acceptable to the Township Risk Manager and the Township Attorney.

4. The Township Clerk in accordance with the provisions of *N.J.S.A.* 40A:11-5(1)(a)(I), is directed to publish a notice once in the official newspaper stating the nature, duration, service and amount of this contract.

5. These contracts shall be charged to budget line item(s)3-01-0020-00100-2-00211 and 3-010020-00130-2-00211. The certification of available funds by the Financial Officer shall be attached to the original of this resolution and shall be maintained in the files of the Township Clerk.
