ORDINANCE INTRODUCTION:

ORDINANCE #323-14

AN ORDINANCE CONCERNING SITE PLAN STANDARDS FOR HANDICAPPED PARKING AND AMENDING SECTION 150 OF THE TOWNSHIP LAND USE ORDINANCE ENTITLED "DEVELOPMENT DESIGN STANDARDS"

WHEREAS, Planning Board Engineer Thomas Lemanowicz, in a September 19, 2013 memorandum to the Township Planning Board, recommended amending the site plan handicapped accessible parking space standards to bring them into compliance with the Americans with Disability Act; and

WHEREAS, the Planning Board agrees with Mr. Lemanowicz's recommendation;

NOW, THEREFORE, **BE IT ORDAINED** by the Township Committee of the Township of Long Hill in the County of Morris, State if New Jersey, that Subsection 151 of the Township land Use Ordinance entitled "Off-Street Parking and Loading" is hereby amended as follows:

Section 1. Paragraph "b" is amended to read as follows:

"151.1 Off-Street Parking

b. Each off-street parking space, excluding those intended for use by drivers with physical disabilities, shall measure nine (9) feet in width and nineteen (19) feet in length (or eighteen (18) feet in length where vehicles overhang a curbed area) and shall be of a usable shape and condition. The above parking space size shall not apply to parallel curb parking spaces which shall measure no less than eight (8)

feet in width by twenty-three (23) feet in length. Parking spaces <u>and accessible</u> <u>routes</u> for drivers with physical disabilities shall be at least twelve (12) feet wide and otherwise conform to the requirements herein .meet the current regulations of the Americans with Disabilities Act of 1990, as amended."

Section 2. Paragraph "e" is amended in its entirety to read as follows:

"e. The number of standard automobile and van accessible parking spaces for drivers with physical disability shall be provided and marked in accordance with the current regulations of Americans with Disabilities Act of 1990, as amended."

Section 3. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

Section 4. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 5. This ordinance shall take effect immediately upon final passage and publication as required by law.

AUTHORIZING PROPERTY LOCATED AT 49 POPULAR DRIVE; KNOWN AS BLOCK 10512, LOT 1 ON THE TOWNSHIP MAPS TO CONNECT TO THE TOWNSHIP WASTEWATER TREATMENT SYSTEM UPON PAYMENT OF THE CONNECTION FEE SET FORTH IN TOWNSHIP CODE SECTION 22-3.1

WHEREAS, Goldcon, Inc. the owner of 49 Popular Drive (Block 10512, Lot 1) has requested a connection to the Township wastewater treatment system to replace a previous connection to that property; and

WHEREAS, the previous connection was a four-family residence which was demolished approximately 24 years ago; and

WHEREAS, the daily flow for the four-family residence, using the formula set forth in N.J.A.C. 7:14A-23.3, was 600 gallons per day; and

WHEREAS, the projected flow for Goldcon's proposed new development, using that same formula, is 374.5 gallons per day; and

WHEREAS, tax lot 1 in block 10512 was in existence when the Township's voluntary sewer ban was imposed on September 13, 2000; and

WHEREAS, the proposed project does not require a sewer extension; and

WHEREAS, paragraph (a)2 of Township Resolution 08-241 provides that: "If the project will replace a building/facility at the same location, which was in existence prior to the effective date of the sewer connection ban, and was or is currently connected to the treatment works subject to the ban, and the replacement facility will create flow equal to or less than the former facility, calculated in accordance with . . . N.J.A.C. 7:14A-23.3 "; and

WHEREAS, paragraph (a)2 of Resolution 08-241 is identical to paragraph (a)2 of N.J.A.C. 7:14A-22.2 which sets forth the exemption criteria for mandatory sewer bans; and WHEREAS, neither Resolution 08-241 nor N.J.A.C. 7:14A-22.22 includes an abandonment provision; and

WHEREAS, the subject property is therefore exempt from the Township's voluntary sewer ban; and

WHEREAS, Township Code Section 22-3.1 provides that "the connection fee . . . for each connection of any property to the sewage system shall be imposed upon the owner . . . at the property so connected" and goes on to set forth the formula for calculating such connection fee; and

WHEREAS, the subject property is not exempt from the connection fee under Section 22-3.2 because that exemption applies only for single-family residences; and

WHEREAS, the subject property is not exempt from the exemption under Section 22-3.7 because the prior connection was demolished more than 2 years ago and, therefore, is deemed to have been abandoned:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey as follows:

The property located at 49 Popular Drive (Block 10512, Lot 1) owned by Goldcon, Inc. is hereby deemed exempt from the Township voluntary sewer ban because it will replace a building at the same location which was in existence prior to the effective date of the sewer ban and was connected to the treatment works subject to the ban and the replacement facility will create flow equal to or less than the former facility calculated in accordance with the criteria contained in N.J.A.C. 7:14A-23.3.

The property is subject, however, to the connection fee set forth in Township Code Section 22-3.1.

Accordingly, the subject property may be connected to the Township wastewater treatment system upon payment of the connection fee calculated in accordance with Township Code Section 22-3.1.

RESOLUTION 14-073 EXTENDING CONTRACT FOR SOLID WASTE AND RECYCLING MATERIALS COLLECTION SERVICE THROUGH 2015

WHEREAS, by Resolution 11-101, adopted, February 23, 2011, Republic Services of NJ, LLC d/b/a MIDCO Waste, 5 Industrial Drive, New Brunswick, NJ 08901, was awarded a three (3) year contract effective February 11, 2011, with contingencies for the years 2014 and 2015, for garbage, bulk and recycling collections, in accordance with its December 16, 2010 bid

WHEREAS, appropriations have been made in the 2014 budget to continue said contract for 2014; and

WHEREAS, a certification of availability of adequate funds has been filed by the Chief Financial Officer, in accordance with the requirements of N.J.S.C. 5:30-14.5;

BE IT RESOLVED, by the Township Committee of the Township of Long Hill, County of Morris, State of New Jersey, that the contract with Republic Services of NJ be continued for 2014 and 2015 for the bid amounts of \$329,368 for 2014 and \$339,250 for 2015.

BE IT FURTHER RESOLVED that this contract shall be charged to budget line item 4-01-26-305-306-201. The certification of available funds by the Township Chief Financial Officer shall be attached to the original of this resolution and shall be maintained in the files of the Township Clerk.

BE IT FURTHER RESOLVED, in accordance with the requirements of N.J.S.A. 40A:11-15 the 2015 extension is contingent upon appropriations being made in the 2015 budgets. If funds sufficient to pay the 2015 charges are not appropriated in that year's budget, this Contract shall be voidable by the Township upon seventy-two (72) hours written notice to the Contractor. In addition, if the contractual amount is included in the 2015 annual budget but if such budget exceeds the limitation imposed by N.J.S.A. 40A:4-45.2 (the CAP law) and said budget is rejected by the voters in a referendum as provided for in N.J.S.A. 40A:45-3a, the contract shall be voidable by the Township upon seventy-two (72) hours written notice to Contractor.
