**ROLL CALL:** Mayor Piserchia, Deputy Mayor Rae, Committeeman Meringolo, and Committeeman Roshto were all present. Committeeman Schuler was absent.

**GUESTS: Presentation by** Gary Finger of the Board of Public Utilities, Division of Economic Development and Energy Policy.

The Mayor introduced Cub Scout Pack 56 from All Saints Church in Millington and presented each of them with a Long Hill Township key chain flashlight.

Mayor Piserchia moved the following OLD Business item to the beginning of the agenda.

#### **OLD BUSINESS:**

Central School Recreation Field

Comm. Meringolo stated that in order to make the June 20<sup>th</sup> application date, a title search would need to be completed. Comm. Meringolo has received a quote for \$350.00 for the title

search. Mayor Piserchia would like to wait until Comm. Schuler returns before authorizing any more expenditures on this project. Deputy Mayor Rae would not like to spend any additional monies. Comm. Roshto noted that he did not think this site was a viable site for this project and made a motion, seconded by Deputy Mayor Rae not to spend any future monies on this project.

The Mayor asked if he could open up the meeting to the public on this matter only prior to voting on anything with regards to this issue.

Joyce Koenig asked if the assessment for the Central School proposed Recreation Field had been ordered, and Mr. Henry answered it had. Ms. Koenig is against the project. Keith Mateo of Chestnut Street presented a letter from a civil engineer to the Committee. Mr. Mateo is against the project. Mike Pavlo is also against the project. Carol Prasa asked that we not apply for the grant if the Committee may not use it. It could possible damage the Township's ability to receive other types of County grants.

Mr. Clapsich had a visual presentation of the widths of the streets in the area, which he feels will not accommodate the increased traffic flow. Mr. Clapsich is against the project. Michael Clapsich, who is legally blind and has to walk in the street because there are no sidewalks in the area, asked the Committee not to pursue the project due to safety concerns.

Tom Dolche and Gloria Aroneo both stated that there were no sewer lines where the proposed bathrooms will be built. Both Charles Arentowicz and Pam Devan noted that at one time the site was a reservoir that was filled in around the early 1950's.

Most of those who spoke were very much against the Central School Recreation Field project. David Hands suggested that the Committee consider applying for the grant for Open Space and then just leaving the area as green open space. This would allow the Township to buy the property from the School, and make the surrounding residents secure that nothing would ever be built in this area.

Comm. Roshto made a motion, seconded by Deputy Mayor Rae to table any further discussions on this project for the remainder of the year. Voice Vote: Comm. Meringolo, no; Comm. Roshto, yes, Deputy Mayor Rae, yes; and Mayor Piserchia, yes.

There was a 10 minute recess, while the many of the residents exited the meeting.

#### **COMMITTEE LIAISON REPORTS:**

- Committeeman Meringolo announced that the Graduation date for Central School is 6/25/14 and for WHRHS is June 23.
- Committeeman Roshto Neil Henry, Brett Trout and Comm. Roshto met with the GIS Dept. at the County. There is opportunity for a shared service with the county to update the tax maps. Appx. \$15,000 20,000, with a \$2,600 annual maintenance fee. This can be done by next year. If our engineer, Paul Ferriero can get the appropriate data to the county it will help reduce the cost of updating.

Comm. Roshto made a motion, seconded by Comm. Rae to have the engineer give the Committee an estimate to accelerate the project. Voice Vote: All in favor.

 The Planning Board is looking for one or more persons for the Citizen's Advisory Committee for the Master Plan.

 Committeeman Rae announced that sub committee for the "Vision" for Central Park (Kurz property) would be May 29<sup>th</sup> at 6:00 PM.

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Long Hill in the County of Morris finds it advisable and necessary to increase its CY 2014 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$328,333.35. in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Long Hill, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2014 budget year, the final appropriations of the Township of Long Hill shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by <u>3.5</u> %, amounting to \$383,055.57, and that the CY 2014 municipal budget for the Township of Long Hill be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
