

**TOWNSHIP OF LONG HILL**  
**TOWNSHIP COMMITTEE MEETING MINUTES**

December 3, 2014

Mayor Piserchia read the following statement:

**STATEMENT OF ADEQUATE NOTICE**

"In compliance with the Open Public Meetings Law of New Jersey, adequate notice of this meeting was posted in the November 20, 2014 edition of the Echoes Sentinel and on the Township website [www.longhillnj.us] as well as the bulletin board in the Municipal Building on November 12, 2014 and has remained continuously posted as the required notices under the Statute. In addition, a copy of this notice is and has been available to the public and is on file in the office of the Municipal Clerk."
