PROHIBITING PARKING ON PARK PLACE (ENTRANCE TO STIRLING LAKE) AND SUPPLEMENTING AND AMENDING CHAPTER VII OF THE TOWNSHIP ENTITLED TRAFFIC

COMMITTEE LIAISON REPORTS:

- Deputy Mayor Meringolo and Committeeman Schuler had nothing to report.
- Committeeman Dorsi reported that Stirling and Millington Fire Companies would begin their joint training on Thursday. He reminded the Township to recycle their cans at DPW in the special bin, where proceeds were sent to the St. Barnabas Burn Center. The Dept. of Agriculture has reported that Long Hill Township is free of any gypsy moth infestation.

DISCUSSION / ACTION ITEMS:

- <u>Central Park Vision</u> Mr. Henry reviewed the drafted RFQ with the Committee and after a brief discussion, Mr. Henry was instructed to move forward and advertise the RFQ.
 - <u>Use of Millington Schoolhouse</u> Mr. Henry presented the Committee with a memo which

summarized all the future prospective uses of the schoolhouse, which per the grant stipulations must be used for community programs. The list was compiled by the Recreation Director, Historic Society and HPAC. The cost to maintain the schoolhouse will be approximately \$14,000.00 per year. This will be funded partially from renting the space but primarily from the operating budget of the Township or the Open Space, Recreation Farmland & Historic Preservation Trust Fund. Mr. Henry will create a fee schedule for renting the space to the public. Open House for Millington Schoolhouse will be November 1, with a high tea, for the kick off to the 150th Anniversary in 2016. Committeeman Dorsi requested that Mr. Henry request a PSE&G energy audit as soon as possible, since winter is fast approaching.

• Whitebridge Road – A memo received from Committeeman Piserchia with regards to his conversation with the FLAP Grant liaison, indicated that there was additional funding for the grant with not as many applicants as expected, He also indicated that Long Hill's chances of getting the entire requested amount was very favorable. A discussion ensued as to whether to forego the grant and pave the road now before the winter sets in or wait to possibly get the grant award and pave the road next year. It was decided by straw poll to wait for the grant outcome and have the DPW get quotes for a 3rd party pot hole patching company to patch the larger pot holes and to close the road to local traffic only. Mr. Henry will research what is necessary to official close the road to local traffic and Mr. Sweeney (DPW) will get some quotes for the pot hole patching. This topic will be added to the next agenda for an update.

OLD BUSINESS: There was no Old Business to discuss

NEW BUSINESS:

The Seniors Club asked Deputy Mayor Meringolo if a railing could be added to the Gillette Walkway as a safety barrier. Mr. Sweeney recommended a metal "street" guardrail and would contact the County to add to their list of guardrail installations. Mr. Sweeney has scheduled an electrician to replace the non-functioning "runway" lights for Main Ave. The light poles on Central Morris and Mercer are the responsibility of JCP&L and he would request repairs from JCP&L.

Mr. Henry noted that the Skyline Drive Pump repair has been delayed but should be completed by late November.

Deputy Mayor reported that he and Mr. Henry are meeting with the Township Planner, Jessica Caldwell to recommend some options for the Thermoplastics site.

MEETING OPEN TO THE PUBLIC:

Rob Walton from JCP& L introduced the PSI program being offered from JCP & L. He also noted that you can report any JCP^&L street light that is not functioning right on their website and it will be addressed in 48 hrs. Mr. Walton also recommended that the Committee consider a special controller for the park field lights that would bring them on one at a time, as opposed to all at once to avoid high upsurge charge from JCP & L. Mr. Henry will contact him for more information about the controllers that would be effective.
