Administrator Henry and Clerk, Cathy Reese were also present, with Attorney Pidgeon present via telephone conference.

**DISCUSSION / ACTION ITEMS**

- Police Department Overtime

The police department has reached their budget for overtime. The Police Chief has asked the Committee to override the budget in order for him to staff the weekends with a minimum of 1 Sergeant and a 2 Officer per shift. Administrator Henry reported that there is surplus of \$44,000 in the regular payroll budget. Committeeman Shuler made a motion, seconded by Committeeman Piserchia to approve the overtime until the October 28<sup>th</sup> Township Committee Meeting. VOICE VOTE: All in favor

Mr. Henry was instructed to have the CFO break down the overtime to date and have Chief Mazzeo attend the October 28<sup>th</sup> meeting. The Clerk was instructed to place this item in Executive session to discuss the various police personnel and to also put it on the public agenda as a discussion item.
