The synthetic turf field is for the intended use of Long Hill Twp. residents and those individuals/groups with a valid permit. NO sports drinks, soda, coffee, or beverage other than water permitted on the field. NO glass or metal beverage containers permitted. NO food permitted on field. NO seeds, nuts, gum or chewing tobacco. NO dogs or animals permitted on field. NO tent stakes. NO sharp objects that could pierce/damage turf. NO metal cleats or muddy footwear. NO golf practice. NO grilling, open flames, pyrotechnics or fireworks permitted anywhere in park. NO bicycles, scooters, skateboards, rollerblades, hover boards, etc., permitted. NO unauthorized vehicles. ONLY authorized personnel shall move goals/field equipment.

25. While on Township property, feeding of wildlife is prohibited.

Stirling Lake Park

- 26. Swimming is only permitted by members of the Lake. At Stirling Lake, access to the water and swimming are only permitted when a lifeguard is on duty. In the colder months, skating is permitted at Stirling Lake by Long Hill residents <u>only</u> when a safety signal is displayed.
- 27. Dogs are not permitted at the Stirling Lake Park.
- 28. Fishing is only permitted in the pond (with proper license) and not in the swimming area side of Stirling Lake.
- 29. The Stirling Lake Pavilion cannot be reserved during regular Stirling Lake swimming hours. Use of the pavilion is intended for all members of Stirling Lake during swimming hours.

BE IT FURTHER RESOLVED by the Township Committee, pursuant to the provisions of Section 11-2 of the Township Code, as follows:

- 1. The Long Hill Township Recreation Department Park Rules and Regulations, which are attached hereto and incorporated herein by reference, are hereby amended as indicated, effective immediately. [Amended March 23, 2016]

ORDINANCE INTRODUCTION:

ORDINANCE #382-16

REFUNDING BOND ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,250,000 REFUNDING BONDS OF THE TOWNSHIP OF LONG HILL, IN THE COUNTY OF MORRIS, NEW JERSEY

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF LONG HILL, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. For the purposes stated in Section 2 of this refunding bond ordinance, negotiable bonds of The Township of Long Hill, in the County of Morris, New Jersey (the "Township"), each to be known as "Refunding Bond" (with such other words incorporated in the title as may hereafter be determined), are hereby authorized to be issued, in one or more series, in the aggregate principal amount of \$4,250,000 pursuant to Section 40A:2-51 et seq., of the Local Bond Law of the State of New Jersey (the "Local Bond Law").

Section 2. The purposes for which said bonds are authorized are as follows:

(a) To pay, fund or refund (i) \$3,925,000 aggregate principal amount of General Bonds of 2007 of the Township, dated February 15, 2007, and maturing on February 15 in each of the years 2018 to 2027, inclusive, and such other bonds of such issue as may be desirable, (ii) interest payable on said bonds to be refunded, if any, until the date or dates said bonds to be refunded mature or are to be redeemed and (iii) redemption premium, if any, payable on said bonds to be refunded.

(b) To pay the costs of issuance of such refunding bonds, including printing, advertising, accounting, financial (including underwriters' discount, original issue discount, bond insurance premium, escrow agent, verification agent and rating agency expenses) and legal expenses, not exceeding \$100,000 (any excess thereof after application to such costs to be applied either to payment of the amounts referred to in section 2(a) hereof or to the payment of debt service on any bonds issued pursuant to this refunding bond ordinance).

Section 3. The following matters are hereby determined, declared, recited and stated:

(a) Further provisions as to the refunding bonds authorized by this refunding bond

ordinance shall be determined by subsequent resolution of the governing body of the Township, or the

determination thereof shall be delegated by such resolution to the Chief Financial Officer or other official

of the Township.

(b) The supplemental debt statement required by the Local Bond Law has been duly

made and filed in the office of the Township Clerk and a complete executed duplicate thereof has been

filed in the office of the Director of the Division of Local Government Services in the Department of

Community Affairs of the State of New Jersey (the "Director"), and such statement shows that, while the

net debt of the Township determined as provided in the Local Bond Law is reduced by the amount of

bonds to be paid, funded or refunded by the bonds authorized by this refunding bond ordinance (i.e.,

\$3,925,000), the gross debt of the Township as defined in the Local Bond Law is increased by the

authorization of the bonds provided for in this refunding bond ordinance by \$4,250,000, and the said

obligations authorized by this refunding bond ordinance will be within all debt limitations prescribed by

the Local Bond Law.

Section 4. Said bonds shall recite that they are issued pursuant to the Local Bond Law,

constituting Chapter 2 of Title 40A, Municipalities and Counties, of the New Jersey Statutes.

Section 5. The Chief Financial Officer of the Township is hereby authorized and

directed to file with the Director, within ten (10) days after the issuance of the said bonds, the documents

required by the provisions of N.J.A.C. 5:30 - 2.5(b).

Section 6. The full faith and credit of the Township are hereby pledged to the punctual

payment of the principal of and interest on the said obligations authorized by this refunding bond

ordinance. Said obligations shall be direct, unlimited obligations of the Township, and the Township

shall be obligated to levy ad valorem taxes upon all the taxable property within the Township for the

payment of said obligations and interest thereon without limitation of rate or amount.

Section 7. This refunding bond ordinance shall take effect twenty (20) days after the

first publication hereof after final passage.

AN ORDINANCE ADOPTING AMENDMENTS TO THE TOWNSHIP LAND USE ORDINANCE AS RECOMMENDED BY THE PLANNING BOARD (DRAFT CHECKLIST/FEE AND ESCROW REVISIONS)

STATEMENT OF PURPOSE: Make minor corrections in the current Land Use Ordinance concerning the Land Use Application Checklist and the Schedule of Fee and Escrow Deposits.

WHEREAS, the Planning Board has recommended certain changes to the Township Land Use Ordinance as outlined in a December 30, 2015 memorandum from Planning Board Planner, Kevin O'Brien, which will make minor technical corrections and remove some inconsistencies in the current Ordinance language;

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey that various sections of the Township Land Use Ordinance are hereby supplemented and amended as follows ¹:

- **Section 1.** Section 167 entitled "Land Use Application Checklist" is supplemented and amended by adding a signature legend for "Certificate of Occupancy" to the other signature legends that are currently at the end of the checklist which is attached to Section 167 as Exhibit "A". (This is one of the legends required to be on plans (see checklist item #19).
- **Section 2.** Items 21, 22 and 23 in Section 182 entitled "Schedule of Fee and Escrow Deposits" are amended to read as follows:

¹Additions in text indicated by underline; deletions by strikeouts.

Item 21 "Each Use Variance: One and two family residential" should be "Use Variance: One and two family residential. One fee and escrow for all variances."

Item 22 "Each Use Variance: Three and more residential" should be "Use Variance: Three and more residential. One fee and escrow for all variances."

Item 23 "Each Use Variance: Nonresidential" should be "Use Variance: Nonresidential. One fee and escrow for all variances."

- **Section 3.** Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.
- **Section 4.** In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- **Section 5.** This ordinance shall take effect immediately upon final passage and publication as required by law.

• Fair Housing Plan from the Planning Board – this item was moved to executive session due to pending litigation.
