WHEREAS, the members of the governing body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

ORDINANCE OF THE TOWNSHIP OF LONG HILL, IN THE COUNTY OF MORRIS, NEW JERSEY, APPROVING AN AGREEMENT OF SALE BETWEEN THE TOWNSHIP AND NEW JERSEY-AMERICAN WATER COMPANY, INC. FOR THE

SALE OF THE TOWNSHIP'S WASTEWATER SYSTEM AND AUTHORIZING A PROPOSAL TO BE PRINTED ON THE BALLOT FOR CONSIDERATION BY THE VOTERS WITHIN THE TOWNSHIP AT THE GENERAL ELECTION ON NOVEMBER 7,2017 PROVIDING FOR THE SALE OF THE TOWNSHIP'S WASTEWATER SYSTEM TO NEW JERSEY-AMERICAN WATER COMPANY, INC.

WHEREAS, the Township of Long Hill, in the County of Morris, New Jersey (the "Township") currently owns and operates a wastewater utility system servicing the residents and property owners (the "Customers") within the geographic boundaries of the Township (the "System"); and

WHEREAS, the Township has determined that is in the best interest of such Customers within the Township to sell the System to an entity with experience and expertise in owning and operating such systems in order to meet all necessary demands associated with such System including all present and future requirements of various state and federal regulatory agencies and to make necessary capital improvements to the System; and

WHEREAS, the Township prepared and distributed a Request for Bids (the "RFB") dated May 3, 2017 requesting bids for the sale of the System pursuant to *N.J.S.A.* 40:62-1 *et seq.* (the "Public Utilities Law"); and

WHEREAS, on June 14, 2017 the Township received one bid from a regulated water and wastewater company, New Jersey-American Water Company, Inc., to purchase the Township's System; and

WHEREAS, based on the review of the above referenced bid, the Township has determined that the bid submitted by New Jersey-American Water Company, Inc. in the amount of \$11,000,000 was the highest responsible (and only) bid; and

WHEREAS, under the terms of the RFB, the Township would sell all of the Township's rights and interests in the land and improvements comprising the System, provided that any purchaser of the System would continue to provide wastewater treatment services to the Customers in accordance with all applicable state and local standards, make all capital improvements necessary to lift the existing sewer ban, and meet other requirements set forth in the RFB; and

WHEREAS, the Township has agreed to the terms of the sale of the System to New Jersey-American Water Company, Inc. pursuant to the terms of the draft Agreement of Sale included in the RFB as revised to reflect certain provisions of the bid submitted by New Jersey-American Water Company, Inc.; and

WHEREAS, the Public Utilities Law requires that in addition to the approval of the Township, the legal voters of the Township must also approve the sale of the System; and

WHEREAS, the Public Utilities Law, specifically *N.J.S.A.* 40:62-5, authorizes the Township to request that the clerk of the County of Morris place the question of the sale of the System

on the ballot used at the next general election in the Township, which is scheduled for November 7, 2017; and

WHEREAS, the Township desires to enter into the Agreement of Sale, subject to the approval of the voters of the Township as set forth in the *N.J.S.A.* 40:62-5 and all other regulatory approvals set forth in the Public Utilities Law.

NOW, THEREFORE, BE IT ORDAINED by Mayor and Committee of the Township of Long Hill, County of Morris, State of New Jersey, as follows:

SECTION I

The recitals are hereby incorporated as if set forth in full herein.

SECTION II

The Township hereby approves the sale of the System to New Jersey-American Water Company, Inc. for \$11,000,000 in accordance with its bid and in accordance with the terms and conditions of the RFB and the Agreement of Sale, subject to the approval of the voters of the Township as set forth in *N.J.S.A.* 40:62-5.

SECTION III

The Agreement of Sale between the Township and New Jersey-American Water Company, Inc. entitled "Agreement between the Township of Long Hill, in the County of Morris, New Jersey and New Jersey-American Water Company, Inc. for the Sale of the Wastewater System" substantially in the form on file in the office of the Township Clerk, is hereby approved with such further changes, insertions and amendments as deemed necessary by the Mayor, in consultation with the Township staff and professionals. The approval of this Agreement of Sale is subject to compliance with the provisions of *N.J.S.A.* 40:62-5 of the Public Utilities Law.

SECTION IV

The Mayor and all other appropriate officials of the Township are hereby authorized and directed to execute the Agreement of Sale and any other documents deemed necessary to effectuate the terms of this Ordinance and to proceed with the regulatory process and approvals required under the provisions of the Agreement of Sale and the Public Utilities Law.

SECTION V

The Mayor and Committee hereby requests and directs the Clerk of the County of Morris to place the following question and explanation on the ballot of the next general election, such to be substantially in the form provided in *N.J.S.A.* 40:62-5 as follows:

PROPOSAL

"Shall the Township of Long Hill, in the County of Morris, New Jersey, be authorized to sell it	its
wastewater utility system, commonly referred to as the sanitary sewer system, to New Jerse	y-
American Water Company, Inc. for the sum of \$11,000,000?"

Explanation

If a majority of the legal voters in the Township vote "yes", the Township of Long Hill will sign an agreement of sale with New Jersey-American Water Company, Inc. for the sewer utility in the amount of \$11,000,000. This agreement provides that New Jersey-American Water Company, Inc. will provide and maintain all wastewater services to the existing customers of the Township's wastewater utility system, commonly referred to as the sanitary sewer system, and will make substantial capital improvements to such system in accordance with the terms of the Agreement of Sale approved by the Township. The service rates to the customers of the Township's System will be subject to approval by the New Jersey Board of Public Utilities from time to time.

SECTION VI

This Ordinance shall take effect as provided by law.

The foregoing ordinance having been introduced and passed on first reading by the Township Committee of the Township of Long Hill, in the County of Morris on Wednesday, June 28, 2017 will be considered for final passage and adoption at a public hearing held at a meeting beginning at 7:30 p.m. on Wednesday, July 26, 2017, at the Municipal Building, 915 Valley Road, Gillette, New Jersey, when and where or at such time and place to which said meeting may be adjourned, all persons interested will be given an opportunity to be heard concerning said ordinance.

Mayor Schuler opened the meeting to the public for comments on Ordinance #402-17. Mr. Neil Lorber, representing the Referendum Validity Caucus urged the Committee to add language clarify the "Wastewater Utility" as the Sewer System. The Committee agreed and add appropriate language to the Ordinance. Mr. Lorber requested the Committee guarantee the sewer workers would be offered employment if they did not move over to JCP&L. The Committee could not give them that guarantee. Joe Connolly agreed with Mr. Lorber that the change of language to include the words sewer system in the referendum question was very important. He also confirmed with the committee that there will be several other meetings held for residents regarding the sale of the wastewater system. With no further comments this portion of the meeting was closed to the public and the Mayor called for a motion to amend the Ordinance as discussed.

Moved by motion of Committeeman Piserchia of the Township Committee of the Township of Long Hill, that Ordinance #402-17 is amended by adding the phrase "Commonly known as the sanitary sewer system" to the referendum question and explanation. Seconded by Deputy Mayor Rae. Roll call vote – all in favor.

Mayor Schuler opened the meeting to the public for comment before voting on the amended Ordinance #402-17. Mr. Lorber confirmed the changed language in the referendum question. Mr. Connolly noted that this referendum vote would have a big impact on the citizens and it was important that they educate themselves before coming to the polls. With no further comments, Mayor Schuler closed the public portion of the meeting and called for a motion to adopt.

Moved by Committeeman Piserchia of the Township Committee of Long Hill, that Ordinance #402-17 is hereby adopted as amended. Seconded by Deputy Mayor Rae. Roll Call Vote – All in favor.

- Verizon cell tower After brief discussion, the Committee directed Attorney Pidgeon to produce a lease for Verizon's use of space on Long Hill Rd. for their shed and communication equipment for their cell tower.

OLD BUSINESS:

- 150th Banners sale confirmation The Committee unanimously voted to put the 150th banners up for sale at \$25 first come, first served. The notice will be put on the website.
- The Cooper Tombstone project in Turtle Rock park is moving forward. Bids are currently being collected.
- The Mitchell Road drain project has received its DEP permit for Phase II.
- The Valley Road project continues and Committeeman Piserchia is in constant contact with the Freeholders to make sure things keep on track.
- Committeeman Piserchia met with the Opiode Task Force and is working with the Police Department on installing a "medicine" drop box.

NEW BUSINESS:

- Committeeman Piserchia recommended the installation of security cameras. The Committee agreed and a committee will be set up to look into the various security problems and solutions.
