[and] will be constructed and/or operated on a tax lot which was in existence prior to the effective date of the ban . . . and the proposed project does not require a sewer extension"; and

WHEREAS, the property located at 35 Morristown Road (Block 13404, Lot 1.04) meets those exemption criteria:

WHEREAS, Section 22-3.1 of the Township Code ordinarily requires a connection fee of \$10,120, however, Code Section 22-3.2 goes on to provide that:

"Single family residences which were in existence on December 28, 1983 shall be exempt from the connection fees set forth in Subsection 22-3.1. Any single family residence which was in existence on December 28, 1983 and which connects to the Township Waste Water Treatment System on or after February 19, 1992 shall be responsible only for a connection fee of \$630.00."; and

WHEREAS, it appears that Mr. Gambino's house was built in 1962;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, that Thomas Gambino is hereby granted permission to connect his property located at 35 Morristown Road (Block 13404, Lot 1.04) to the Township wastewater treatment system upon payment of the \$630 connection fee in accordance with Section 22-3.2 of the Township Code entitled "Exemptions."

WHEREAS, Appraisal Systems, Inc. has submitted a proposal to assist the Assessor in conducting the 2019 annual reassessment at a lump sum cost of \$25,000; and

WHEREAS, it is not practicable to obtain competitive quotations, in light of the fact that Appraisal Systems, Inc. was deeply involved in the town-wide reassessment;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the

Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- 1. The Mayor and Clerk are hereby authorized to execute a contract with Appraisal Systems, Inc. to provide assistance to the Township Tax Assessor during the 2019 annual reassessment that will be conducted during 2018.
- 2. Appraisal Systems, Inc. shall be compensated \$25,000.
- 3. This approval is contingent upon the Township Committee's deciding to proceed with the annual reassessment program for 2019, and the receipt of both state and county approval for such annual reassessment program.

WHEREAS, a resolution authorizing this municipality to apply for the 2017 Recycling Tonnage Grant will memorialize the commitment of this municipality to recycling and to indicate the asset of Long Hill Township Committee to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed;

NOW THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, wishes to file an application and endorses such application with the State of New Jersey Department of Environmental Protection and designates Thomas Sweeney, Recycling Coordinator, to ensure that the application is properly filed:

ADMINISTRATOR'S REORT:

- JCP&L and NJ Transit have been contacted to participate in the installation of new lights at the Gillette train station.
- The energy audit should be completed shortly.
- The sump pump at the TIFA site has been inspected and is not violating any ordinances. It is a gravitational pump being used to push drainage from a slop sink up a hill to connect with the sewer pipe.
- We are still waiting for the contract from JCP&L for the electric charging station.
- Oaks road project is currently being outlined and will go out to bid in April with an award of contract expected in May and work expected to begin in July.
- The Mitchell Road project is going out for bid.
- The Gillette school crossing project has been completed.
- Matthew Kantor Park trail project has received DEP approvals/permits and will be moving forward.
- Millington Schoolhouse HVAC and electrical systems are being worked on and the offices are ready to be leased.
- The Township Committee authorized the relocating of a stop sign and stop bars for Mountain Ave/Meyersville Rd./Long Hill Rd. intersection. The Committee recommended a new stop light at Lackawanna and Valley Road. The Township's share of the cost will be approximately \$30,000. The PD will also do a trial period of restricted turn times on Lackawanna.
- Verizon Nodes on New Vernon Road no update at this time.
- County Road Paving New Vernon Road form Meyersville Road to the Twp. Line and Division Ave. from Valley Rd. to Long Hill Rd scheduled for 2018.
- A memorandum of understanding was signed with Community Options for a group home. The final location has yet to be determined.

- In follow up to a resident's question at the last meeting, it has been verified that almost 100% of sewer fees are used for sewer operations, and not involved in the general budget.
- Our recycling programs are going well and need to continue, seemingly low figures quoted in a recent article reflected the fact that commercial and industrial locations are not recycling as well as residents.

NEW/OLD BUSINESS:

- The Committee authorized the administrator to move forward in trying to get some of the Township properties off the ROSI list.
- Committeeman Rae reported that Superintendent Acevedo was looking forward to working with the "A Way Out" Opiate awareness task force. Lt. Naga reported that the teachers had attended a Narcan training course.
