**WHEREAS,** fatal opioid overdoses in Morris County rose from 43 in 2015 to 64 in 2016 and exceeded that number in 2017; and

WHEREAS, no community is immune from the opioid scourge; and

WHEREAS, the Township formed an Opiate Task Force known as "A Way Out" in 2017 after Morris County Chief Assistant Prosecutor Brad Seabury spoke to Long Hill Township residents in April; and

WHEREAS, "A Way Out" seeks to connect those affected by opiate abuse with local, county and state resources to get them the help that they need; and

**WHEREAS,** "A Way Out", in conjunction with the Prosecutor's Office, is responsible for the installation of a prescription medication drop box in the Township Police Department lobby; and

WHEREAS, Officer-in-Charge Ahmed Naga of the Long Hill Township Police

Department has noted that the policing of drug abuse in recent years has shifted emphasis from criminalization to treatment; and

**WHEREAS,** "A Way Out" is following the lead of the County Prosecutor's Office and other agencies which have sought to reduce the stigma associated with drug abuse; and

**WHEREAS,** "A Way Out" seeks to address the crisis locally through four central initiatives: education, detection, prevention and recovery; and

**WHEREAS**, the task force has met with School Superintendent Edwin Acevedo and other school district professionals to discuss opiate awareness efforts in the Township's K-8 school system;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- 1. The creation of the opioid task force known as "A Way Out" which is described in the preamble is hereby formalized.

**WHEREAS,** *N.J.S.A.* 40A:14-146.11 provides in relevant part that:

"No person may commence his duties as a special law enforcement officer unless he has successfully completed a training course approved by the commission and no special law enforcement officer may be issued a firearm unless he has completed the basic firearms course approved by the commission for permanent regularly appointed police . . . "; and

WHEREAS, N.J.S.A. 40A:14-146.11 further provides that:

"Class II [Special] Officers shall be authorized to exercise full powers and duties similar to those of a permanent, regularly appointed full-time police officer. The use of a firearm by an officer of this class may be authorized only after the officer has been fully certified as successfully completing training as prescribed by the commission . . . "; and

**WHEREAS,** *N.J.S.A.* 40A:14-146.14 provides that:

"Special law enforcement officers may be appointed for terms not to exceed one year, and the appointments may be revoked by the local unit for cause after adequate hearing, unless the appointment is for four months or less, in which event the appointment may be revoked without cause of hearing . . . "; and

WHEREAS, Officer in Charge Ahmed Naga has recommended that the individuals named below be appointed as a Class II Special Police Officers, subject to satisfactory completion of their medical and psychological examinations and background investigations:

#### TOWNSHIP OF LONG HILL ORDINANCE #408-18

## AN ORDINANCE ESTABLISHING THE TOWNSHIP WASTEWATER TREATMENT SYSTEM AS A MUNICIPAL PUBLIC UTILITY EFFECTIVE JANUARY 1, 2018

**WHEREAS,** "Municipal Public Utility" is defined in *N.J.S.A.* 40A:1-1 as "any water, sewer, electric power or gas system, or any combination thereof or any public parking system, or any other utility, enterprise or purpose authorized to be undertaken by a local unit from which it may receive fees, rents or other charges"; and

**WHEREAS,** *N.J.S.A.* 40A:26A-4 provides that, "A local unit may . . . acquire, construct or operate a sewerage facility upon a determination by the governing body of the local unit . . . that the public health, safety or welfare can best be assured by the acquisition, construction or operation of sewerage facilities by the local unit . . ."; and

#### **WHEREAS,** *N.J.S.A.* 40A:26A-5a provides that:

"One or more local units adopting an ordinance or resolution in accordance with N.J.S.40A:26A-4 are authorized and empowered . . . [t]o acquire, construct, improve, extend, enlarge or reconstruct and finance sewerage facilities, and to operate, manage and control all or part of these facilities and all properties relating thereto . . . "; and

#### WHEREAS, N.J.S.A. 40A:26A-5g provides that:

"One or more local units adopting an ordinance . . . in accordance with N.J.S.A.~40A:26A-4 are authorized and empowered . . . [t]o fix and collect rates, fees, rents and other charges in accordance with N.J.S.A.~490A:26A-1 et seq . . ."; and

WHEREAS, N.J.S.A. 40A:4-45.2 provides that:

"In each budget year . . . , whenever any municipality shall have

transferred to any local public utility . . . , during the immediately preceding budget year, or at any time during the current budget year prior to the final adoption of the budget, any service or function funded during the immediately preceding budget year, either partially or wholly, from appropriations in the municipal budget, the municipality shall deduct from its final appropriations under which its permissible expenditures are calculated pursuant to this section the amount which the municipality expended for that service or function during the last full budget year throughout which the service or function so transferred was funded from appropriations in the municipal budget.";

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- **Section 1.** There is hereby established in the Township of Long Hill (the "Township") a municipal public sewer utility, to be effective January 1,2018.
- **Section 2.** The Township wastewater treatment system heretofore operated by the Township shall be operated as a municipal public sewer utility as defined in and subject to the provisions of Title 40A of the Statutes of the State of New Jersey. All rents, rates, fees or other charges received by the Township in connection therewith shall be kept in funds separate from other Township revenues to be used only for the purposes of such municipal public sewer utility.
- **Section 3.** The local public sewer utility shall include the Township's wastewater treatment plant and all appurtenant structures and facilities, including but not limited to all sewer mains, pump stations and other wastewater treatment equipment and facilities under the jurisdiction of or maintained by the Township.
- **Section 4.** Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.
  - **Section 5.** In case any article, section or provision of this ordinance shall be held

invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 6.** This ordinance shall take effect immediately upon final passage and publication as required by law.

AN ORDINANCE PROVIDING THAT SEWER USE CHARGES AND SEWER CONNECTION FEES SHALL BE PAID INTO THE TOWNSHIP'S MUNICIPAL PUBLIC SEWER UTILITY AND AMENDING CHAPTER XXII OF THE TOWNSHIP CODE ENTITLED "SEWERS"

WHEREAS, simultaneously with the adoption of this ordinance, the Long Hill Township Committee is adopting Ordinance #408-18 entitled "An Ordinance Establishing the Township Wastewater Treatment System as a Municipal Public Utility, Effective January 1, 2018"; and

WHEREAS, Section 22-20 of the Township Code entitled "Purpose" in Article III entitled "Sewer Use Charges," and Subsection 22-3.1, entitled "Connection Fees," in Article I entitled "Sewerage Connections," in Chapter XXII of the Township Code entitled "Sewers" need

to be amended to reflect the creation of the Township's Municipal Public Sewer Utility;

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, that Chapter XXII of the Township Code entitled "Sewers" is hereby amended as follows:

**Section 1.** Section 22-20 entitled "Purpose" in Article III entitled "Sewer Use Charges" is hereby amended to read as follows:

#### "22-20 PURPOSE.

"The purpose of this article is to disestablish the confirm the creation of a Municipal Public Sewer Utility in the Township and, in lieu thereof, to provide for the collection of sewer use charges which shall be paid into the Municipal Public Sewer Utility general revenues of the Township. The charges shall, as nearly as may be practical, defray the actual costs of the operation of the sewer plant and such other costs as the Township Committee may decide to include, but not limited to a reserve for uncollected sewer fees, a reserve for future/planned debt related to the waste water plant or capital improvements associated with the wastewater system not incurred with debt."

**Section 2.** Subsection 22-3.1 entitled "Connection Fees," in Article I entitled "Sewerage Connections," is amended to read as follows:

#### "22-3.1 Connection Fees.

"In addition to the sewer use charges set forth in Article III of this chapter, a separate charge in the nature of a connection fee or tapping fee for each connection of any property to the sewerage system shall be imposed upon the owner or occupant at the property so connected, and shall be paid into the Municipal Public Sewer Utility."

**Section 3.** Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

**Section 4.** In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section

or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 5.** This ordinance shall take effect immediately upon final passage and publication as required by law.

The foregoing ordinance having been introduced and passed on first reading by the Township Committee of the Township of Long Hill, in the County of Morris on Wednesday, January 24, 2018 will be considered for final passage and adoption at a public hearing held at a meeting beginning at 7:30 p.m. on Wednesday, February 28, 2018 at the Municipal Building, 915 Valley Road, Gillette, New Jersey, when and where or at such time and place to which said meeting may be adjourned, all persons interested will be given an opportunity to be heard concerning said ordinance.

**MOVED** by: Committeeman Meringolo of the Township Committee of Township of Long Hill that Ordinance #409-18 is hereby adopted. **SECONDED** by: Committeeman Schuler.

- Ms. Malool: Confirmed that our recycling numbers have increased since the 2015-2016 number that appeared in the Echoes Sentinel. Phase two of the Morristown Road Grant was approved. The extension for Oaks Road Grant was approved. Lighting for the Gillette station still in progress with location and hours of operation to be discussed. FEMA has started its 90 day appeal process for the new Flood Maps. Individuals can follow the appeal process as well as the Township itself. Long Hill has not had a great deal of change in its maps.
- Mr. Schuler noted that the Budget Committee had had a successful first meeting and the budget is looking to be in good shape.

Board meeting and was concerned about the lack of progress on the Master Plan and provided the NJ Municipal Master Plan Manual to be distributed to the Planning Board and Master Plan Committee to aid them in their work.
