LIAISON REPORTS:

- Committeeman Verlezza reported that the Rec Committee met and discussed sending out Community Forum Survey Monkey to get ideas from residents on programs and how to improve facilities at Stirling Lake to make itself sustaining. Committeeman Verlezza asked the Township Committee to allow Watchung Hills High School Tennis Team to use Kantor Field Tennis Courts 2:30-4:30 during week while the High School Tennis Courts are under construction. Committeeman Verlezza reported that the Vision Committee met and discussed the proposed park project. Walking the proposed trail and looking into applying for trail grants in the future.
- Committeeman Schuler added to Vision Committee report. The land diversion is ongoing and will probably will take an additional 9-10 months. Hoping to get at least one walking trail from Morristown to Railroad.
- Committeeman Dorsi reported that DPW will be collecting Christmas Trees for one more week.
 The aluminum can trailer was taken out and received \$200 which was donated to Saint
 Barnabus, Committeeman Dorsi reported OEM put out email about Smart 911 that they received
 a message from vendor about emergency message notification. Program requires that you
 update your account every 6 months.
- Mayor Rae reported police statistics and urged residents to utilize the different police initiatives including Vacant House Check Program and Operation Good Morning.

ADMINISTRATOR'S REPORT:

- The Central Park Land Diversion application was heard by the DEP and concerns were there was a potential easement that wasn't adequately concerned, valuations of properties and only conceptual plans were presented. Will be receiving full report later in the week.
- FLAP grant is moving forward, the Federal Highway Administration is giving \$60,000 and Fish and Wildlife is giving \$100,000.
- Clarified that White bridge Road Bridge will be repaved from a County grant this April.
- Work will begin on the light on Mountain and Valley scheduled for Monday, January 27.
- Township Committee adopted the Municipal Consent Ordinance which now allows New Jersey
 American Water to apply to the BPU. BPU will need to approve the purchase which can take 4-6
 months. In meeting with NJAM it was decided Long Hill will send out sewer bills for all of 2020.
- New Jersey Transit will be replacing the culvert under railroad track in Millington near Old Mill Road and Oaks Road in spring 2020. Don't anticipate any train delays but will confirm closer to replacement.
- Administrator Malool reported that the stain glass window at Millington Schoolhouse has been broken for 7 years and isn't actually stained glass. Lisa Scanlon received five quotes to replace ranging from \$1,300 to \$3,860 to replace with glass or stained glass. Looking at old pictures the actual schoolhouse had a wooden louver. Administrator Malool has reached out to HPAC with how they would like to continue.

DISCUSSION:

- Committeeman Dorsi and DPW Director Gallo have noticed illegal dumping at DPW. Discussion
 ensued about enforcing with cameras, signage and sticker options. Over the next week there will
 be someone monitoring.
- Planning Board Redevelopment was tabled as Committeeman Verlezza would like to ask questions to Planner Jessica.
- Administrator Malool requested we switch back to Edmunds as the current system isn't user-friendly. CFO recently negotiated a 10% decrease from last year's quote making it \$32,100.
 Quote included five years of record conversion and yearly maintenance fee would be \$5,357.
 Township Committee approved.

- There are inconsistences in the current tree ordinance and the Township Committee discussed how to proceed. The conversation was tabled until a further meeting.
- Committeeman Dorsi and Administrator Malool shared JCPL would replace the lights on valley road. There would be clarification if there would be a cost at a further meeting.

- Darren DeAngelis spoke about the speeding and rock blasting concerns with the Cross Hill Road drainage and paving project.
- David Farrell spoke how the town previously tried to correct the drainage problem and hit rock, appreciates the concern about Cross Hill and would like to see curbing to alleviate water on his property.
- Alan Pfeil spoke about the uniqueness of Cross Hill Road and how he would like to see the full project proposed by Engineer Paul Ferriero completed.
- Brian Pedersen spoke about how he would like to see the full project proposed by Engineer Paul Ferriero completed.
- Dennis Tepperman spoke about uniqueness of Cross Hill Road, would like to see the drainage issue fixed but to keep the road the same size. Spoke about the concern of the trees that would be taken down.
- William Larkin applauded the call for public comments from the Township Committee and received clarification about the rock concern.
- Don Farnel spoke about the NJ Transit replacing the culvert received clarification about the permit
 process. Don Farnel spoke about the tree ordinance and clear cutting lots. Don Farnel received
 clarified of the scope of the Vision Committee and shared the Paul Ferriero has completed plans.
- Karen Meleta spoke about tabling the Redevelopment study discussion and how she would like to be able to have public comment when it comes back on the agenda.
- Thomas Cifelli received clarification as to why the Redevelopment study discussion was tabled.

ORDINANCE NO. 450-20

AN ORDINANCE GRANTING CONSENT TO NEW JERSEY-AMERICAN WATER COMPANY, INC. TO PERMIT THE CONSTRUCTION, EXPANSION AND MAINTENANCE OF SEWER COLLECTION AND TREATMENT FACILITIES ON PUBLIC AND PRIVATE PROPERTY IN THE TOWNSHIP

WHEREAS, New Jersey American Water Company, Inc. ("Company") is a regulated public utility corporation of the State of New Jersey seeking from the Township of Long Hill ("Township") the approval of an exclusive and perpetual franchise to provide sewer service within the Township, and the municipal consent of the Township to permit said Company to extend sewer service and its related facilities to the Township; and

WHEREAS, the Company has requested the approval of an exclusive and perpetual franchise to provide sewer service for the entire Township, pursuant to N.J.S.A. 48:2-14; and

WHEREAS, the Company has requested the consent of the Township as required by N.J.S.A. 48:3-11 and 48:3-15 for the use of the streets, with such consent limited to the fifty (50) year duration set forth in N.J.S.A. 48:3-15, including the consent of the Township pursuant to N.J.S.A. 48:13-11, as amended, to lay its pipes, valves, pumps, manholes and other equipment beneath and restore such public roads, streets and places as it may deem necessary for its corporate purposes, free from all charges to be made for such privilege, provided that said pipes shall be laid at least three feet (3') below the surface and shall not in any way unnecessarily obstruct or interfere with the public travel or cause or permit other than temporary damage to public or private property, and the Township desires and permits the Company to construct and maintain sewer collection and treatment facilities on and along roads, streets and places at locations to be designated by the Township;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Long Hill, in the County of Morris, State of New Jersey, as follows:

Section 1. The Township hereby grants to the Company, its successors and assigns, in perpetuity, the exclusive franchise to provide sewer service within the Township pursuant to N.J.S.A. 48:2-14.

Section 2. The Township hereby grants to the Company, its successors and assigns the municipal consent to use the streets pursuant to N.J.S.A. 48:3-11 and 48:3-15, with such consent limited to the fifty (50) year duration set forth in N.J.S.A. 48:3-15; as well as the municipal consent required pursuant to N.J.S.A. 48:13-11 as amended, without charge therefore, as the same may be required in order to permit the said Company to add to, extend, operate and maintain said sewer collection

and treatment facilities on public and private property located in the Township. The privilege granted herein shall include the construction installation and maintenance of sewer collection and treatment facilities on and along the Township roads, streets and places at locations as the Township shall designate from time to time.

Section 3. Certified copies of this Ordinance, upon final passage, shall be sent to the Company who shall forward same to the New Jersey Department of Environmental Protection and the Board of Public Utilities of the State of New Jersey.

Section 4. The consent granted herein shall be subject to the Company's complying with the applicable Township Ordinances, State of New Jersey Statutes and any New Jersey Administrative agency's rules and regulations which apply to the subject matter of this Ordinance; and that the Mayor, Clerk and other Township officials are authorized to execute the documents and agreements necessary to effectuate the municipal consent and to protect the rights of the public involved.

Section 5. All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section 6. Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 7. This Ordinance shall take effect when the closing takes place on the sale of the Township wastewater treatment system to New Jersey American Water Company, Inc.

SOCIAL AFFAIR PERMIT [MILLINGTON VOLUNTEER FIRE CO. NO. 1]

WHEREAS, Millington Volunteer Fire Co. No. 1 has submitted an Alcoholic Beverage Control Application to the State of New Jersey for a Comedy Night to be held on October 5, 2019 at the Millington Volunteer Fire Co. No. 1, 1891 Long Hill Road, Millington, New Jersey 07946; and

WHEREAS, the Chief of Police has reviewed the application and has no objection to the granting of a special permit to be issued to the applicant to sell alcoholic beverages at the affair to be held on the date and premises noted, subject to, however, the following conditions:

- 1. The consumption of alcoholic beverages shall be restricted to the area as outlined in the site plan supplied with the application. No alcoholic beverages shall be possessed or consumed in any area not designated on this site plan.
- 2. No person under the age of 21 shall be served alcoholic beverages. Millington Volunteer Fire Co. No.1 members or it's designee shall be responsible for verifying the ages of those patrons who wish to consume alcoholic beverages, check identification to verify age, and monitor the area to prevent "hand off's."
- 3. No person assumed to be under the influence of alcohol shall be served, permitted to walk, or allowed to drive from the Millington Volunteer Fire Co. No. 1 or the designated area.

4. Alcoholic beverages shall only be served and/or consumed between the hours of 10:00 am and 11:00 pm on October 5, 2019

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Long Hill, in the County of Morris, State of New Jersey as follows:

- 1. The Township Committee, the licensing authority of the municipality, has no objection to the granting of a special permit and consents thereto with the special conditions as outlined by the Chief of Police.
- 2. The Township Clerk is hereby authorized to approve the municipal certification on the application and submit to NJ ABC electronically.

RESOLUTION 20-054

RESOLUTION RELAXING REQUIREMENT THAT GARAGE BE CONSTRUCTED ON 57 OLD FORGE ROAD (BLOCK 12604, LOT 1) PRIOR TO SALE

WHEREAS, the Harold White Irrevocable Trust is the owner of property located at 57 Old Forge Road, Block 12604, Lot 1 (formerly Block 133, Lot 1) ("subject lot"); and

WHEREAS, the September 21, 1993 resolution authorizing the subdivision of the subject property provided that, "Any contract for the sale of and in the conveyance of these premises to a third party shall require the construction of a two (2) car garage . . . "; and

WHEREAS, this same condition was also set forth in the subdivision deeds that effected the subdivision; and

WHEREAS, John M. Losinger of the Saiber law firm was appointed by court order dated October 1, 2019 as the third-party trustee for the Harold White Irrevocable Trust for the limited purpose of determining whether the subject property can be sold; and

WHEREAS, by court order dated December 18, 2019, Attorney Losinger was specifically authorized to take all steps necessary to facilitate the sale of the property, including asking the Township to modify, relax or waive the requirement that the two-car garage be constructed prior to sale of the property; and

WHEREAS, Attorney Losinger, in a January 9, 2020 letter, formally requested that the "Township permit the property to be marketed and sold to a third party without a two (2) garage being constructed prior to closing, that the Township not take any action to enforce the requirement prior to the closing, and that the requirement be temporarily suspended, thus allowing the contract of sale to 'require a purchaser to complete the construction of a two (2) car garage within one hundred eighty (180) days of closing, weather permitting . . . "; and

WHEREAS, the Township Committee previously agreed on June 26, 2019 that it would not require the trustee to construct a garage before conveying it a nonprofit purchaser; and

WHEREAS, the Township Committee finds that it is in the best interest of the Township to relax the requirement as requested by the third-party trustee;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- 1. The Township Administrator is hereby authorized to sign a copy of Attorney Losinger's letter, thereby agreeing to and accepting the terms and conditions as set forth in his January 9, 2020 letter and as outlined above.
- 2. Among other things, the contract of sale shall "require a purchaser to complete the construction of [the] two (2) car garage within one hundred eighty (180) days of closing, weather permitting."

WHEREAS, the Township of Long Hill Office of Emergency Management, designated by the New Jersey State Police, Office of Emergency Management has submitted an application for Sub-grant Award that has been required by the said New Jersey State Police Office of Emergency Management for the subgrant award period of July 1, 2019 through June 30, 2020; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill, County of Morris, in the State of New Jersey that the Township Committee authorizes the Long Hill Township Office of Emergency Management to participate in the grant program and agrees to accept the \$10,000.00 award for the Long Hill Township "OEM" for emergency management purposes for EMAA FY 2019.

WHEREAS, N.J.A.C. 7:14A-22.22 provides in relevant part that:

"A sewer ban exemption may be granted for projects . . . if the proposed project will have a total projected flow of 600 gallons per day or less . . . [and] will be constructed and/or operated on a tax lot which was in existence prior to the effective date of the ban . . . and the proposed project does not require a sewer extension"; and

WHEREAS, the property located at 93 Morristown Road (Block 13404, Lot 5) meets those exemption criteria; and

WHEREAS, Sections 22-3.1 and 22-3.3 of the Township Code require a connection fee of \$10,120; and

WHEREAS, the Township is in the process of selling its wastewater plant to NJ American Water Company; and

WHEREAS, NJ American Water Company has agreed to allow connections subsequent to the closing for those properties for which the connection fee has been paid to the Township in full prior to the date of closing of sale. Connection fees are not refundable.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, that Arthur Czarnecki c/o 93 Morristown Road, is hereby granted permission to connect the property located at 93 Morristown Road (Block 13404, Lot 5) to the Township wastewater treatment system upon payment of the \$10,120 connection fee in accordance with Sections 22-3.1 and 22-3.3 of the Township Code.
