LIAISON REPORTS:

- **Committeeman Dorsi** reported that DPW is no longer doing deliveries for mulch, All Saints Church is in need of donations for the food pantry and encouraged residents to do the Census.
- **Deputy Mayor Piserchia** spoke about how the First Aid Squad was doing a great job.
- **Mayor Rae** reported there are 44 patients that have tested positive for COVID 19 in Long Hill and all first responders have been tested for the antibodies. The COVID 19 Task Force is turning its attention to reopening the town and its businesses. Mayor Rae spoke about the 1962 Proclamation that designated May 15th as Police Officers Memorial Day. Mayor Rae reported the police statistics and spoke about the Governors Executive Order resuming community

engagement. Also spoke about a scam targeting senior citizens informing that their grandchild is in need of bail money. There have been 90 incidents reported statewide.

- **Committeeman Schuler** warned about online scams and urged residents to be vigilant when clicking on emails.

ADMINISTRATOR'S REPORT:

- **Administrator Malool** spoke about a preconstruction meeting with the County for Division Ave for milling and paving with a target date of June 1st. The County anticipates the job will take two weeks and the road will be open with no detour.
- **Committeeman Schuler** and **Committeeman Dorsi** spoke about Mountain and Valley interaction.

DISCUSSION:

- Stirling Lake – Director Scanlon spoke about the opening Stirling Lake. There will be a reevaluation in June with a target opening date of July 4th with guidance from the State.

OLD/NEW BUSINESS:

- Deputy Mayor Piserchia spoke about a section on Meyersville Road that needs to be milled and paved. Director Gallo will follow up with County as it is a safety hazard.

ANNOUNCEMENTS:

- Recreation Director Lisa Scanlon asked if you are interested in sending in a picture for the Memorial Day video please send to digitally by weekend.
- Deputy Mayor Piserchia spoke about doing a parade for Memorial Day with social distancing. Chief Naga would like to get clarification on the Executive Order.

- Dennis Sandow spoke about an article from the 1934 issue of Mountain Echoes.
- Gary Giankas spoke about the potential Memorial Day parade.
- Tom Grosskopf spoke about the Board of Education budget hike. Mayor Rae clarified they were invited to speak at the Township Committee meeting and urged Mr. Grosskopf to attend the Board of Education meeting.

ORDINANCE 458-20
AN ORDINANCE CONCERNING SEWER USER RATES AND AMENDING
CHAPTER XXII OF THE TOWNSHIP CODE ENTITLED SEWERS"

BE IT ORDAINED by the Township Committee of the Township of Long Hill in the County of Morris, New Jersey that Chapter XXII of the Township Code entitled "Sewers" is hereby amended as follows:

Section 1. Section 22-23 entitled "User Rates" is hereby amended to read as follows:

22-23 USER RATES

22-23 USER RATES.

The following sewer service and usage fees are hereby established effective January 1, 2020, and shall remain in full force and effect until revised by ordinance duly adopted by the Township Committee:

- A. All residential sewer users shall be charged a service fee of \$0.00 per year per unit.
- B. All commercial and industrial sewer users shall be charged a service fee of \$0.00 per year per unit.
- C. Residential sewer users that are metered shall be charged a sewer usage fee at the rate of \$18.27 per thousand gallons.
 - 1. The gallons used shall be the total water metered (Actual Usage) for the six (6) winter months preceding the billing year. By example, in the billing year of 2020, the gallons are determined from the six (6) months January through March and October through December 2019. The months excluded are: April through September 2019.
 - 2. Water consumption figures for each user will be obtained from the water company servicing the premises or by the Township Sewer department if the meter is not serviced by the water company.
 - 3. If the meter is not read or incorrectly read for one or more months of the usage period as determined by the Sewer Utility Collector, the amount charged for those months shall be equal to the approximate average monthly usage among other billable months during the same period.
- D. Commercial and industrial sewer users that are metered shall be charged a sewer usage fee at the rate of \$18.27 per thousand gallons.
 - 1. The gallons used shall be the total water metered (Actual Usage) for the six (6) winter months preceding the billing year. By example, in the billing year of 2020, the gallons are determined from the six (6) months January through March and October through December 2019. The months excluded are: April through September 2019.
 - 2. Water consumption figures for each user will be obtained from the water company servicing the premises or by the Township Sewer department if the meter is not serviced by the water company.
 - 3. If the meter is not read or incorrectly read for one or more months of the usage period as determined by the Sewer Utility Collector, the amount charged for those months shall be equal to the approximate average monthly usage among other billable months during the same period.
- E. Sewer Users that are not metered shall be charged a usage fees follows: Residential units: \$575 per unit

Commercial or Industrial units: \$1200 per unit

- F. If a user has multiple water sources, the usage fee shall be the combined total of each source as specified in subsection 22-23c or d. if metered and subsection 22-23e. if unmetered. Only one service fee shall be applied.
- G. The Township Committee may require a water meter to be installed by any sewer user utilizing a well or other private water system at the property owner's expense.
- H. Each user who is a resident of this Township and who was sixty-five (65) years of age or older during the prior calendar year shall be entitled annually, upon submission of a claim on proper forms, to a deduction of forty (\$40.00) dollars from his or her sewer use charge as established hereinabove.

Section 2. Any and all other ordinances or parts thereof in conflict or consistent with any of the terms thereof are hereby repealed to such extent as they are so in conflict or inconsistent.

Section 3. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. This ordinance shall take effect immediately upon final passage and publication

**ORDINANCE 459-20
CALENDAR YEAR 2020
ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO
ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Long Hill in the County of Morris finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$380,437.96 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Long Hill, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Long Hill shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to

\$380,437.96, and that the CY 2020 municipal budget for the Township of Long Hill be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
